

EDITOR'S NOTE BY JANSWAN

Originally the brainchild of President Kennedy, the National Endowment for the Arts (NEA), was formed in 1965 under President Lyndon B. Johnson. The NEA mission is to "nurture creativity, to elevate the nation's culture, and to sustain and preserve the country's many artistic creations."¹ The NEA provides grant money to artists and art organizations with the first grant provided to the American Ballet Theater. Early grants also included monies to sixty visual arts organization and artists, including Aberdeen native Robert Motherwell. The NEA emphasized new American art and art movements.

In 1968, just a few years after its founding, the NEA faced criticism by Republican members of congress who feared the *avant garde* art supported by the NEA would "bypass the cultural norms of the American majority" or as "state censorship of more traditional styles." I wonder what art and artists they are referring to. "Culture wars" are nothing new.

In the 1980's the NEA was again under attack over a photograph by Andres Serrano, a Catholic, that showed a blurred Christ on the crucifix seen through a golden liquid titled "Piss Christ." The Piss Christ photograph raised the ire of Republican Senators Al D'Amato and Jesse Helms because the artist had received \$5,000 from the NEA. Serrano received death threats and hate mail (sound familiar?) and he lost other grants due to the controversy. The outcome of the Republican outrage was substantial cuts to the funding of the NEA under President Ronald Reagan.

In 1997, during a retrospective of Serrano's work at the National Gallery of Victoria, a Catholic Archbishop sought an injunction to stop the exhibit of *Piss Christ*, but the injunction was not granted and the piece was exhibited. However, two teenagers attacked it with a hammer during the show. Gallery officials, of course, received death threats and the show was cancelled. *Piss Christ* was also featured on television by British Channel 4 in 1991, and on "Down by Law" (a show on identity politics and disobedience) in 2006. In 2011, a print was vandalized beyond repair by Christian protestors in an art museum in France. In 2022, *Piss Christ* was sold at auction by Sotheby's for \$145,162. In 2023, Serrano was blessed by Pope Francis and given a thumbs-up sign. Serrano said of the experience, "*I was very happy that the church understands that I am a Christian artist and I am not a blasphemous artist. I'm just an artist.*"

The Trump administration's 2021 budget proposed \$30 million to the NEA, an 82% cut in funding, to provide "sufficient funding for orderly termination of all operations of the NEA." Under President Biden, the proposed NEA budget for 2024 is \$211 million. Our vote in 2024 could save funding for America's art and culture.
